Information to data subject as per Section 13 of Legislative Decree no. 196/2003

SUBJECT: Information to data subject as per Section 13 of Legislative Decree No. 196/2003 on the protection of individuals and other subjects with regard to the processing of personal data.

Informative sources and purposes of the use of the personal data belonging to you

The personal data belonging to you that Idea R S.n.c. owns and will process, have been

- collected directly from you (Customer/Supplier) and/or our Employees;
- collected from agents and Representatives, and refer to the relationship between you and Idea R S.n.c. (e.g. for the issuance of a bid/tender, during the supply of products/services, etc.);
- freely inserted by the users while compiling the forms on our Internet sites;
- collected automatically when navigating our Internet sites (e.g. web cookies).

Cookies

Methods of the processing of the personal data belonging to you

These personal data are and will be processed according to the law, following the principles of lawfulness and correctness, in order to protect your own privacy and rights, manually and/or with the use of electronic means for data storage, management and transmission (information and telecommunication systems).

According to Legislative Decree no. 196/2003, we inform you that all personal data belonging to you are and will be:

- processed fairly and lawfully;
- collected for specified, explicit and legitimate purposes;
- accurate and, where necessary, kept up to date.
- adequate, relevant and not excessive in relation to the purposes for which they are collected and/or further processed.

Subjects to whom the personal data belonging to you can be communicated

We inform you that the personal data belonging to you can be communicated for the indicated purposes to the following subjects and organizations that work together with Idea R S.n.c. for the implementation of our business and the legal and contractual obligations related, such as:

- the Tax Authority, the Social Security Agency and, where applicable, the Police Office;
- suppliers of freight and other accessory services;
- factoring firms, agencies for debt collection and anti-fraud investigations;
- banks and credit Institutions, in relation of our company finance management;
- insurance agencies;
- the company auditors/chartered accountants and consultants for administrative, fiscal and contractual matters.

The personal data belonging to you might also be communicated to other companies within our network and transferred to foreign countries, also over UE's borders.

While, these personal data are not and will not be spread out for any reason.

Right to access personal data and other rights (section 7)

We inform you that Section 7 of Legislative Decree no. 196/2003 confers specific rights to individuals and other subjects, resumed as follows: the data subject shall have the right to obtain confirmation as to whether or not personal data concerning him/her exist and communication of such data in intelligible form; to be informed of the source of the personal data, the logic applied to the processing and the purposes and methods of the processing; to obtain erasure, anonymization or blocking of data that have been processed unlawfully, and updating, rectification or, where interested therein, integration of the data; to object, on legitimate grounds, to the processing of personal data concerning him/her.

Mandatory and optional personal data to be provided

We inform you that your denial to provide us with your data may affect the fulfillment of contractual obligations with you and that providing necessary data for fulfillment of laws and regulations is mandatory.
